AMENDMENT TO DECLARATION OF  
CAROLINA LAKE BEACH VILLA CONDOMINIUMS

CAROLINA LAKE BEACH VILLAS, INC., a North Carolina corporation with its principal place of business in Cumberland County, North Carolina, hereinafter referred to as DECLARANT, together with DERWOOD H. GODWIN and wife, MARIE S. GODWIN, WILLIAM G. HAYES and wife, JUDITH N. HAYES, KENNETH MARVIN NORRIS and wife, MYRA M. NORRIS, BARRY L. HOOKER and wife, DEBORAH N. HOOKER, OSCAR L. NORRIS and UNITED HOMES OF FAYETTEVILLE, INC., d/b/a UNITED REALTY & CONSTRUCTION, INC., being all of the purchasers of condominium units from DECLARANT and hereinafter collectively referred to as HOMEOWNERS, do hereby amend the DECLARATION CREATING UNIT OWNERSHIP OF PROPERTY dated the 4th day of May, 1982 and recorded in Book 1202, Page 0145 in the New Hanover County Public Registry;

WHEREAS, said Declaration provided in Paragraphs 3.2, 7.1 and 10.13 that it could be amended to add subsequent phases to said Condominium project; and

WHEREAS, said Declaration provided in Paragraph 14.1 that it could be amended to alter the percentage of ownership in the common areas and facilities appurtenant to each unit; and

WHEREAS, said declaration provided in Paragraph 13 that it could be generally amended; and

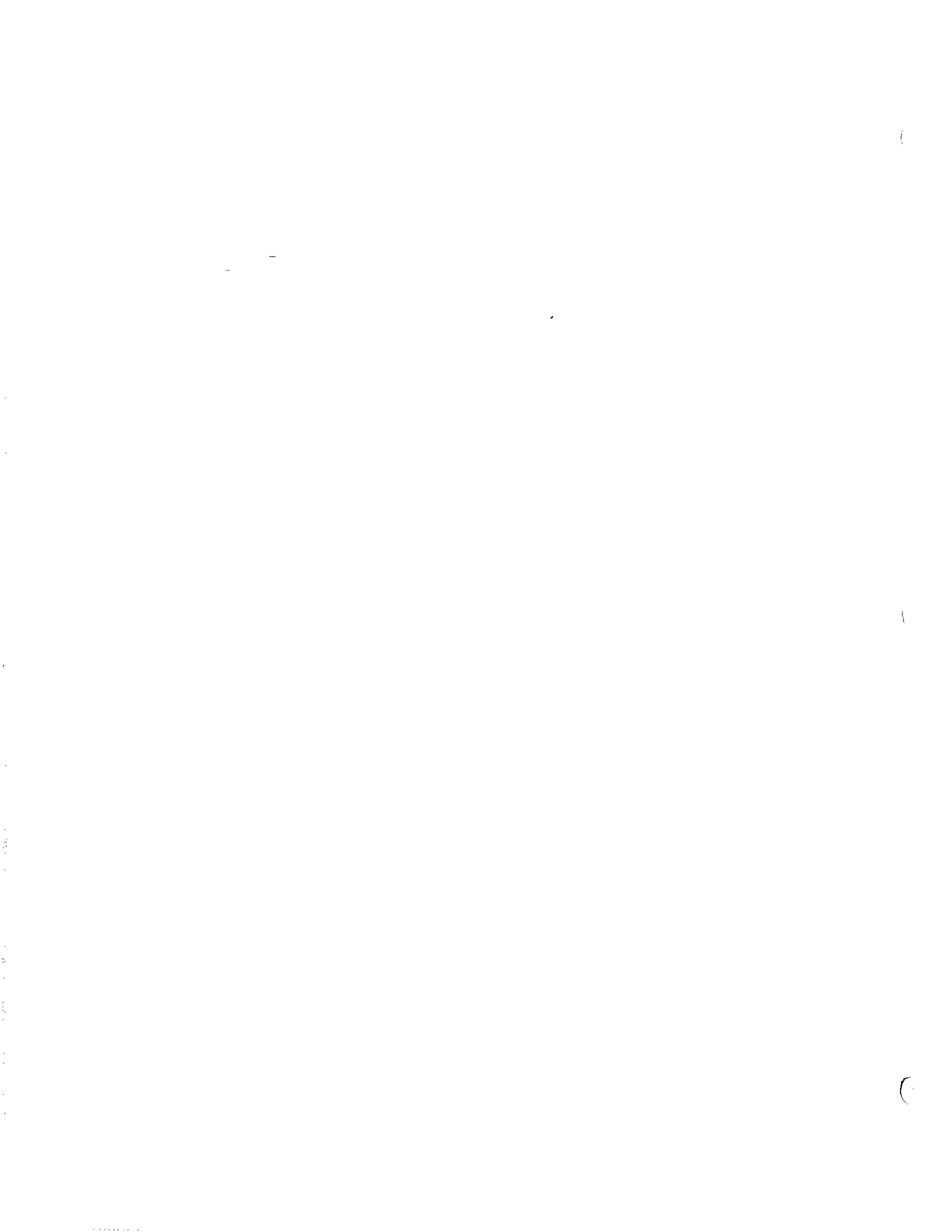
WHEREAS, DECLARANT and HOMEOWNERS hereby amend said Declaration to add Phase II to the operation of the Declaration and to otherwise amend the Declaration as set out hereinafter, all amendments being as if they were incorporated in the original document; and

WHEREAS, a meeting was duly held in accordance with the provisions of the By-Laws of CAROLINA LAKE BEACH VILLAS HOMEOWNERS ASSOCIATION, INC., recorded in Book 1202, Page 0191 of the New Hanover County Registry;

NOW, THEREFORE:

1. (a) DECLARANT does hereby amend the Declaration of Carolina Lake Beach Villa Condominiums recorded in Book 1202, Page 0145 to add the additional eighteen (18) units, hereinafter Phase II, as described in the Declaration and does hereby submit the land described in Exhibit B of the Declaration, a copy of said Exhibit B being attached hereto, and improvements located thereon to the Condominium project known as Carolina Lake Beach Villas with Exhibit E of the aforesaid Declaration now being in full force and effect, and being substituted in place thereof for Exhibit D. Filed simultaneously hereby, marked as Exhibit C, and expressly made a part hereof consisting of 12 pages is a survey of the land and graphic descriptions and plans of the improvements constituting Phase II of the Condominium project, identifying the condominium units, common areas and facilities, as said terms were defined in the Declaration, and their respective locations and approximate dimensions.

1. (b) The materials used in the construction of the additional units are of comparable quality as those used in the original units and the architectural style of the additional units is substantially the same as the original units.

2. DECLARANT and HOMEOWNERS do hereby further amend Paragraph 8.0(e) of the Declaration by substituting for Paragraph 8.0(e) of the Declaration the following new Paragraph 8.0(e) to read as follows:

8.0

(e) No advertising signs, billboards, unsightly objects, or nuisances shall be erected, placed or permitted to remain on the property, including but not limited to the individual units or common or limited common areas, nor shall the property or any part of it be used in any way or for any purpose which may endanger the health of or unreasonably disturb the owner of any residence or any resident thereof. No business activity of any kind whatever shall be conducted at any building or on any portion of the property, provided, however, the foregoing covenants shall not apply to the business activities, signs and billboards of the Declarant, its agents or assigns, during the construction and sale period and thereafter for such periods of time as Declarant, its agents or assigns, shall desire to maintain a sales or rental office.

3. DECLARANT and HOMEOWNERS do hereby amend the Declaration by substituting in place of Paragraph 8.0(f) of the Declaration a new Paragraph 8.0(f) to read as follows:

8.0

(f) No animals, livestock or poultry of any kind shall be raised, bred or kept on any part of the property, this prohibition shall not include common domesticated animals, subject to the Rules and Regulations of the Carolina Lake Beach Villas Homeowners Association governing such pets.

4. DECLARANT and HOMEOWNERS do hereby amend the Declaration by substituting in place of Paragraph 8.0(m) of the Declaration a new Paragraph 8.0(m) to read as follows:

8.0

(m) So long as the Declarant shall retain ownership of any units, it may utilize any such unit or units for sales or rental offices, models or other usage for the purpose of selling or renting units within said project. The Declarant may assign this limited commercial usage right to any other person or entities as it may choose.

5. These amendments do not divest any owner or mortgage holder of any portion of the dwelling unit and does not materially alter the plan and development as set forth in the Declaration.

6. Pursuant to the rights and powers reserved by the DECLARANT and granted to DECLARANT by each unit owner and lender in accordance with the Declaration, the DECLARANT, for and on behalf of itself, each unit owner and each lender holding mortgages on such units, hereby gives consent to the execution and recordation of this Amendment to Declaration, and does hereby consent to all other acts necessary to give effect to this Amendment.



7. The HOMEOWNERS join in the execution of this Amendment and the Amendment to this Declaration in accordance with the Declaration.
