# EASEMENT AND ACKNOWLEDGMENT OF RIGHTS AS TO 48 ACRES IN NORTHERN SECTION OF CAROLINA BEACH

This Easement and Acknowledgment of Rights as to 48 acres in Northern Section of Carolina Beach ("Easement and Agreement") is entered into between Town of Carolina Beach, a North Carolina Municipal Corporation, (hereinafter "Town"), Spinnaker Pointe Unit Owners Association, Inc., a North Carolina nonprofit corporation, (hereinafter "Spinnaker Pointe"), and Oceana Owners Association, Inc., a North Carolina nonprofit corporation, (hereinafter "Oceana").

The Town, Spinnaker Pointe, and Oceana, in consideration of the mutual covenants set forth herein, agree as follow:

#### 1. The Town, Spinnaker Pointe and Oceana agree that:

a-The rights of Spinnaker Pointe Unit Owners Association, Inc., and Oceana Owners Association, Inc. and all of their members, to use and enjoy said property as common area to their respective developments, as referred to in that certain agreement, Deed and Deed of Easement recorded in Book 1755, Page 613, in the New Hanover County Registry, and as further preserved and referenced in Deed from Oceana Limited Partnership to the Town of Carolina Beach, as recorded in Book 1955 at Page 131 of the New Hanover County Register of deeds, are perpetual rights which will be honored and respected by the Town of Carolina Beach in Perpetuity.

b-The Town by the execution of this Easement and Agreement, and in consideration of the mutual covenants contained herein, does grant, bargain sell and convey unto Spinnaker Pointe Unit Owners Association Inc., and Oceana Owners Association Inc., and all of their members, to run with the title of the individual member to their ownership interest in the condominium units of Spinnaker Pointe, and/or their lots in Oceana, a perpetual right and easement over that certain lot or parcel of land situated in the Town of Carolina Beach, County of New Hanover and more particularly described on Exhibit A, attached hereto and incorporated by reference, to use and enjoy said property as common area to their respective developments, as referred to in that certain Agreement, Deed and

- c-Spinnaker Pointe and Oceana, in consideration of the mutual covenants contained herein, acknowledge the rights of the Town of Carolina Beach to exercise dominion and control over said property, subject to the right of said Associations and their respective members, as contained herein, pursuant to that certain Deed from Oceana Limited Partnership to the Town of Carolina Beach as recorded in Book 1955 at Page 131 of the New Hanover County Registry.
- 2. This Agreement constitutes the entire agreement between the Town, Spinnaker Pointe and Oceana with respect to the subject matter hereof, and no statements, promises or inducements made by any party or agent of any party that are not contained in this Agreement contract shall be valid or binding. This Agreement may not be enlarged, modified, or altered except in writing signed by the parties and endorsed thereon.
- 3. This Agreement may be recorded in the Office of the Register of Deeds of New Hanover County by any party hereto.
- 4. This Agreement shall inure to the benefit of and is binding upon the parties hereto, their successors and assigns. It is expressly agreed upon that this Agreement shall inure to the benefit of the individual members of Spinnaker Pointe and Oceana, by virtue of their membership in those associations, their unit ownership, and their interest and percentage ownership in the condominium common areas. Further, said individual members of Spinnaker Pointe and Oceana are intended third-party beneficiaries of this Agreement with full rights to apply and enforce the same against the Town.
- 5. The terms and conditions of this Agreement shall be construed, interpreted and enforced under and by virtue of the laws of the State of North Carolina.
- 6. If any paragraph or provision of this Agreement is found void or unenforceable, the unenforceable paragraph or provision shall be severed, and the remainder of this Agreement shall be enforced as written.


