AMERICIENT TO DECLAFATION CREATING UNIT OWNEPSHIP SUN SKIPPER, PHASE 1

FIRST: The legal description contained in the second paragraph of Article III, located on page 6 of said Declaration is hereby amended by adding thereto the following real property:

*BEING all of Lot 7, in Block 27, according to a map of the Northern Section of Carolina Beach recorded in Map Book 3, at Page 67, of the New Hanover County Registry."

SECOND: Subparagraph C. of Article III of said Declaration is hereby deleted in its entirety and the following substituted in lieu thereof:

"C. In the event Declarant adds to the real property subject to this Declaration all of the real property described in this Article III, the Declarant covenants and agrees that no more than a total of eighty-four (84) units will be added to the six (6) units in Sun Skipper, Phase 1; and"
